## 1. Introduction and Acceptance of Terms

Welcome to Legit Athletics. By accessing or using our Site, placing an order, or using our 3D design builder, you acknowledge that you have read, understood, and agree to be bound by these Terms. If you do not agree to these Terms, you must not use our Site or Services.

Legit Athletics reserves the right to modify these Terms at any time. Changes will be effective immediately upon posting to the Site. Your continued use of the Site following any changes constitutes your acceptance of the revised Terms.

## 2. Eligibility

You must be at least eighteen (18) years of age or the age of majority in your jurisdiction to place an order or enter into a binding agreement with Legit Athletics. By using our Services, you represent and warrant that you meet this eligibility requirement.

Our Site features a real-time 3D builder tool that allows customers to upload logos, select colors, add player names and numbers, and customize designs according to their preferences.

## 4. Custom Orders Policy

### 4.1 Nature of Custom Products

All products ordered through Legit Athletics are custom-manufactured to your exact specifications. Each item is produced specifically for your order and cannot be resold or repurposed.

### 4.2 Order Confirmation

Once you submit an order and receive an order confirmation email, your order is considered final. Please review all design details, sizes, player names, numbers, and other customization options carefully before submitting your order.

### 4.3 No Cancellations or Modifications

**Due to the custom nature of our products, orders cannot be canceled, modified, or changed once production has begun.** Production typically begins within twenty-four (24) to forty-eight (48) hours of payment confirmation. If you need to make changes, contact us immediately at the email address provided below; however, we cannot guarantee that changes will be possible.

### 4.4 Order Accuracy

You are solely responsible for ensuring the accuracy of all information submitted with your order, including but not limited to:

- Spelling of team names and player names
- Player numbers
- Size selections for each individual item
- Color selections
- Logo placement and orientation

Legit Athletics is not responsible for errors in orders resulting from incorrect information provided by the customer.

## 5. Pricing and Payment

### 5.1 Pricing

All prices listed on the Site are in United States Dollars (USD) unless otherwise specified. Prices are subject to change without notice. The price in effect at the time of order submission will apply to your order.

### 5.2 Payment

Payment must be made in full at the time of order placement. We accept major credit cards, debit cards, and other payment methods as indicated on the Site. Orders will not be processed or moved into production until payment has been successfully received and cleared.

## 5.3 Taxes

You are responsible for all applicable taxes, duties, and fees associated with your order. Sales tax will be calculated and added to your order total where required by law.

# 6. Shipping and Delivery

## 6.1 Shipping Methods

Legit Athletics ships via reputable carriers including but not limited to UPS and FedEx. Shipping options and estimated delivery times will be displayed at checkout.

## 6.2 Production and Processing Time

Custom orders require production time before shipping. Estimated production times will be provided at the time of order and may vary based on order complexity, quantity, and current demand.

## 6.3 Delivery Estimates

Delivery estimates are provided for informational purposes only and are not guaranteed. Legit Athletics is not responsible for delays caused by shipping carriers, weather, customs, or other circumstances beyond our reasonable control.

## 6.4 Risk of Loss

## 7.2 Defective or Incorrect Items

We stand behind the quality of our products. If you receive an item that is defective due to manufacturing error or if we made an error in producing your order that does not match your approved design, please contact us within seven (7) days of delivery. We will, at our sole discretion:

- Replace the defective or incorrect item(s) at no additional cost; or
- Issue a refund for the defective or incorrect item(s).

To initiate a claim, you must provide photographic evidence of the defect or error along with your order number.

## 7.3 Damaged Shipments

If your order arrives damaged due to shipping, please document the damage with photographs and contact us within forty-eight (48) hours of delivery. We will work with you and the shipping carrier to resolve the issue.

# 8. 3D Builder and Design Tools

## 8.1 Use of the 3D Builder

Our 3D builder tool is provided for the purpose of designing and customizing products available for purchase on the Site. You agree to use the 3D builder only for its intended purpose and in compliance with these Terms.

## 8.2 Design Approval

By submitting an order, you confirm that you have reviewed and approved the final design as displayed in the 3D builder. The preview images are intended to provide an accurate representation of the final product; however, slight variations may occur.

## 8.3 Color Disclaimer

**Colors displayed on computer monitors and mobile devices may vary from the actual printed or manufactured colors.** Differences in monitor settings, screen calibrations, and display technologies can affect how colors appear. Legit Athletics cannot guarantee an exact color match between on-screen previews and finished products. Such variations do not constitute a defect and are not grounds for a return or refund.
